7. Full payment is due at the time of reservation
8. Cancellations MUST be made one week prior to event or NO refund will be given.
9. Any gathering considered dangerous, a disturbance of the peace or endangering public property is subject to closure.
10. The City of Valdez Parks & Recreation Department reserves the right to refuse rental to any organization/individual.
11. Renter may be subject to a \$50.00 cleaning/damage fee if the facility is not properly cleaned after the event.
12. COV P&R reserves the right to charge & bill for any last minute onsite usage requests within the above fee schedule.
